**SUMMARY:** The rule amends the NCUA's regulations governing the responsibilities of a federally insured credit union (FICU) to obtain an annual supervisory committee audit of the credit union. The rule implements recommendations outlined in the agency's Regulatory Reform Task Force's Regulatory Reform Agenda and will provide flexibility to FICUs. Specifically, the Board is: (1) replacing the Supervisory Committee Guide with a simplified Appendix to Part 715; (2) eliminating two audit types that FICUs seldom use; and (3) eliminating a specific deadline for outside, compensated persons to deliver written audit reports to FICUs.

**RECOMMENDED ACTION:** Recommend the Board approve publication of the final rule.
